STUD SERVICE CONTRACT

NOTE: for any contract to be legally binding, the document should be witnessed.

The service at stud of the male (breed) Chihuahua (name) H&H Smokey Robinson @ Kkc

is hereby contracted for the following bitch: (name)

under the following terms:

BITCH OWNER agrees to provide:

- Written veterinary certification that the bitch has been tested negative for brucellosis within the prior thirty (30) days of the breeding,
- Current vaginal cytology demonstrating the stage of her estrus cycle and if any bacterial diseases are present in the vagina that may cause venereal diseases or problems with conceiving,
- Legible photocopy of the AKC registration certificate of the bitch,
- · Legible photocopy of her pedigree, and
- Proof of current shots and wormings.

<u>BITCH OWNER</u> also agrees to have the bitch bathed, groomed, and free of fleas or parasites before shipping or delivering bitch for breeding.

<u>STUD OWNER</u> reserves the right to refuse stud service if the bitch:

- Is not AKC registered,
- Is deaf,
- Is not sound in temperament and/or conformation, or
- Appears unhealthy, obese, or in poor condition.

<u>STUD OWNER</u> guarantees to practice due diligence in providing the necessary environment for an actual mating (and "tie") ONLY, and does not guarantee pregnancy nor puppies, living or dead, will ensue from this mating. BITCH OWNER hereby releases from

responsibility STUD OWNER, descendants and heirs from any and all liabilities and/or damages to said bitch while she is in the care of STUD OWNER.

If the bitch fails to be in whelp (pregnant), BITCH OWNER must give notice not later than sixty-five (65) days after the date of mating. STUD OWNER agrees to provide a repeat stud service for no additional stud fee to the same bitch in her next season, or another bitch with approval of the STUD OWNER, under the same terms of this Contract in the event that one or more puppies do not result from this breeding.

The fee for the stud service is payable at the time of service, or terms as follows:

The owner of the dam identified above agrees on this date: / / (initialed:) that the stud fee of \$500.00 must be paid to the stud dog owner before the stud dog owner will sign the AKC litter registration application.

NOTE: The <u>American Kennel Club</u> takes the position that the <u>owner of the sire is required to sign</u> an application to register a litter certifying only to the fact that a particular dam was bred to the sire identified on the Litter Registration Application form on a specified date of mating, <u>unless there is an agreement signed</u> by all parties concerned in which it is specifically set forth that the owner of the sire is not obligated to sign an American Kennel Club litter registration application form until such time as the stud fee has been paid.

Additional charges for board and transportation of the bitch shall be charged at the following rates:

- a. Board at \$7.00 per day.
- b. If shipping needed, transportation to/from the airport at \$ 15.00 per trip.
- c. Board charges are waived for 5 days, after which the above charges shall apply.
- d. Additional veterinary charges deemed appropriate by the stud dog owner shall be charged to the bitch's owner at their usual rates.

BITCH OWNER agrees to pay any and all incurred expenses, including stud, bitch, veterinarian, shipping, delivery, boarding, and any other miscellaneous expenses, if required, associated with or incurred for the purpose of breeding this Chihuahua bitch, and acknowledge that STUD OWNER is not liable or responsible for any expenses incurred in association with the breeding of this Chihuahua bitch.

BITCH OWNER certifies that they will not sell offspring from this breeding to any agent, pet store, puppy mill, kennel, or individual or agent of an individual whose purpose is mass production, wholesaling or retailing of Chihuahua, i.e., any mass-producing kennel or business. BITCH OWNER will immediately pay a penalty of \$1000.00 to STUD OWNER for

each puppy offered in breach of this condition.
